In order for us to be able to accept your patient for urogynaecology review and treatment, referring GPs/medical specialists are required to provide:

#### EXCLUSION CRITERIA: UROGYNAECOLOGY CLINICS

The following conditions are not routinely seen at Werribee Mercy Hospital:

• Patients that are being treated for the same condition at another Victorian Public Hospital



### **REFERRAL PROCESS: UROGYNAECOLOGY CLINIC**

The clinical information provided in your referral will determine the triage category. The triage category will affect the timeframe in which the patient is offered an appointment.

If the condition is required **immediate** assessment or admission a referral to the Emergency Department (ED) should be attended to. Please contact 03 8754 3000 and refer the patient to the ED for clinical review.

Urgent (seen within 30 days of referral receipt)	Non-urgent	
The patient has a condition that has the potential to deteriorate quickly with significant consequences for health and quality of life if not managed promptly. Examples include:	The patient's condition is unlikely to deteriorate quickly or have significant consequences for the person's health and quality of life if specialist assessment is delayed beyond one month. Examples include:	
<ul> <li>Reserved for categories of malignancy whether suspected or confirmed</li> </ul>	<ul> <li>Uterine and vaginal prolapse</li> <li>Pelvic Floor disorders including pelvic organ prolapse</li> <li>Bladder pain/Interstitial cystitis/urethral syndrome</li> <li>Retrocele / cystocele / enterocele</li> <li>Urinary irritation symptoms</li> <li>Recurrent UTI's</li> <li>Stress and urge incontinence</li> </ul>
